SPECIAL CONSIDERATIONS & REASONABLE ADJUSTMENT POLICY

7th March 2023

Introduction

Real First Aid Ltd recognises its responsibilities as a training provider for candidates with learning difficulties or disabilities. In implementing a policy, Real First Aid Ltd aims to ensure that no candidate is treated less favourably than others on the grounds of such difficulties or disabilities.

1. Statement of Reasonable Adjustments

Real First Aid Ltd will aim to make reasonable adjustments when a candidate is placed at a disadvantage to others with regard to tuition and assessment, due to a learning difficulty or disability.

2. Disability – Reasonable Adjustment

Real First Aid Ltd is able to offer reasonable adjustments to those candidates who are considered to have a physical or mental impairment that is likely to last less than 6 months.

2.1. Practical Observations

There is a requirement for candidates to demonstrate all practical Learning Outcomes of the course to achieve a pass.

We may, on occasion, make reasonable adjustment where this is not possible, for example, if a candidate has a plaster cast due to a recent wrist injury they may not be able to effectively perform CPR but may describe the process and identify key elements of performing the process. This may be accepted as the wrist injury is a short-term issue for the candidate and one can reasonably expect the candidate to be able to effectively perform the role of a First Aider once the cast is removed and the candidate's injury has healed.

2.2. Physical contact

Where the candidate is not willing to physically contact another candidate, the Trainer or the Assessor, we cannot make reasonable adjustment.

It would be not be possible to accurately assess a candidate who is not willing to touch another candidate or the trainer. Some assessments such as CPR and checking and

opening an airway can be performed on a CPR mannequin but performing a head-to-toe assessment, or the Safe Airway Position cannot. There is no requirement for EFAW or FAW trainers to provide full body mannequins.

If a candidate is not willing to touch a Trainer or other Candidate in a safe, controlled environment, one cannot reasonably assume that they would be willing to touch a casualty in reality, therefore one cannot, in good conscience, expect the candidate to be able to fulfil their role as a First Aider.

3. Application for Reasonable Adjustment

All applications from candidates will be considered on an individual basis by Real First Aid Ltd.

4. Situations that cannot have been foreseen

Special consideration may be given to candidates in situations that could not have been foreseen, such as temporary illness, or injury.

This information must be accompanied by a doctor's medical certificate or other relevant evidence for the claim to be accepted by Real First Aid Ltd.

Even though Real First Aid Ltd should be notified of all special consideration cases at least four weeks prior to the examination, we acknowledge this is not always possible. Please inform us <u>prior</u> to the examination even if the four-week deadline has passed. We will try to make reasonable adjustments but this cannot be guaranteed; Real First Aid Ltd may have to advise that a candidate defers their examination.

5. Student Responsibility

It is the responsibility of candidates to ensure that we are aware of their individual assessment

needs at the time of registering for an assessment, so that reasonable adjustments can be

made.

Real First Aid Ltd has to ensure that any reasonable adjustment made does not over-

compensate for a condition, giving the candidate with special requirements an unfair advantage

over others.

7. Pre-formatted media

Requests for tape recordings, Braille or large print papers should be made to us at the time of

registering for an assessment (earlier if at all possible). These shall be made available if they

already exist.

Real First Aid Ltd is not able to provide alternative bespoke examination or assessment material

in Braille or other languages.

If we agree to a computer being used, this must be provided by Real First Aid Ltd. The

computer's memory must be wiped and it must not provide access to the internet, to ensure

that no additional advantage is gained by the candidate.

8. Recording & Confidentiality of information

Please note that Real First Aid Ltd is obliged to record disability-related information because of

statutory regulatory body requirements, and to inform relevant staff because of the

arrangements that may have to be made. This information will be held confidentially under the

EU General Data Protection Regulation 2016/679

Note: "relevant staff" includes invigilators and examination centre staff who need to be aware of the assessment arrangements made in order to assist their smooth administration.

9. Special Consideration process

After notification, Real First Aid Ltd will send the candidate an acknowledgement by letter, email, fax or telephone (whichever method of communication is appropriate to the candidate's needs).

The candidate will be informed, by an appropriate method of communication, of any arrangements which have been made regarding taking an examination or assisting the process of writing an assignment. A note will be made in the candidate's record.

Any scripts not in handwritten format will be printed off and sent to examiners or moderators as part of the usual examination process.

Assessment results will be communicated in a manner appropriate for the candidate.

10. Expectations of Study and Examination Centres by Real First Aid Ltd

Training and Examination Centres should ensure relevant staff members know Real First Aid Ltd's policy, and that candidates have been made aware that reasonable adjustments can be made to assist them in examinations and assignments.

Training and Examination Centres should ensure that all reasonable adjustments made in examinations or in assignments are known by the relevant personnel within the institution, on an agreed confidential basis.

11. Monitoring and Evaluation

Data will be collected at the time of declaration by those candidates disclosing any disability or other impairment. This will be compared with national data.

Confidentiality will be maintained in accordance with the EU General Data Protection Regulation 2016/679.

A Reasonable Adjustment report is produced for the consideration of each Examination Board (in February and July each year), which is compared with national data. Names of candidates are not included in this report.

All findings are reported to the Director, who will, if necessary, enhance or alter the department's procedures.

12. Declaration
